## Our response is:

- Islington's housing offer to care leavers is included in our care leaving policy and can be found at following link:

- Islington has strong support for children in care and care leavers verified by OFSTED and other internal and external mechanisms. Islington does not specifically have a Strategy for Children in Care
- Mental Health Strategy Islington currently has a Vulnerable Children Needs
   Assessment which examines the prevalence and impact of a wide range of issues
   affecting the vulnerability of children, which includes poor mental health and the
   needs of looked after children and care leavers. A summary factsheet from this Needs
   Assessment forms part of the JSNA. Islington's approach to the JSNA is to use
   factsheets as chapters of the JSNA. However, the Evidence Hub website
   (<a href="https://evidencehub.islington.gov.uk">https://evidencehub.islington.gov.uk</a>) which holds these factsheets forms the wider
   evidence base for the JSNA, and the full Vulnerable Children Needs Assessment is
   available on this website.

A factsheet on children and young people's mental health is currently being drafted and this will form part of the JSNA going forward. This includes consideration for the higher prevalence of mental health conditions amongst looked after children.
